Support teachers and students in our school wide implementation of our discipline and reward systems. Provide supervision and support in the classroom and support CCSS and STEM/Arts programs at the school. Implement and supervise programs that increase parent involvement. Support and implement programs and activities that support student, family and staff satisfaction with the overall program. Provide intervention alternatives and support for teachers through the use of the Assistant Principal and various STEM and CCSS programs at the school site. Interventions will focus on use of technology with SBAC connecting reading and math with the use of technology.

**Expected Outcome:**

CORE Survey data related to student, parent, and staff socio emotional and cultural factors will increase from 2014-2015 results to 2015-2016. SBAC 2015-2016 results as compared to SBAC 2014-2015 results, CORE Survey results, over 85% of computers operational at all times in both computer labs. Support to teachers/classes during CCSS Inquiry and Investigation Periods through the Librarian and the technology college aide. Survey results will show an increase in satisfaction from staff, student and parents on the CORE Survey. Decrease in the number of suspensions by 10% when comparing the 2014-2015 school year to the 2015-2016 school year. JiJi Math student data will show high rate of use. By the end of the year, 28% of students will meet or exceed the Common Core Standards overall on the SBAC (4% increase) in ELA. a. By the end of the year, 18% of students will meet or exceed expected Common Core Standards overall on the SBAC (increase of 5%) in Mathematics. Self-Efficacy data will also show student percentage increase in Global, Math, and ELA by 5%.
