Intervention Focus:

1. In an effort to exceed A-G and high school graduation targets set by the district, the school will establish mandatory intervention tutoring sessions for students earning multiple D/Fs at each progress and quarter grading period.
2. In an effort to continue the development of a positive, energetic, and safe campus environment, support is needed to increase buy-in and involvement in student activities and foster the growth of clubs, ASB, and Yearbook.
3. Students experiencing attendance issues will meet with administrative staff to develop goals to ensure regular attendance.
4. Provide incentives to students who show growth in grades and/or attendance.
5. Provide an online career and college support program to facilitate the development of college and career readiness and cohesive planning for post high school education.
6. Provide after school tutoring to all students for additional support.
7. Provide Independent Study class to assist students with getting on track for graduation.

Expected Outcome:

1. 80% of the student body will complete A-G course work with a C or better.
2. 95% of the student body is on-track for graduation.
3. Meeting or exceeding the state and district targets for discipline referrals and suspensions for student conflicts and fights.
4. Increased awareness and understanding of college requirements and the connections between school and career readiness.
5. Increased student involvement in activities including clubs, intramurals, ASB and Yearbook.

Students will be mandated to report one time per week to review School Loop Progress Reports, discuss academic goals, and work to complete missing assignments.
