Attention Bidder:

You are hereby notified of the following changes, additions, or deletions to the bid titled above. Also see below questions asked verbatim and the responses:

The following change shall be made to the bid listed above.

1. The quotation information on page 70, bid item #38 of the bid should request the following information separately: the case price, CRV price, case price with CRV and Extension with CRV.

Please discard page 70 of the subject bid and replace with the revised page attached.

2. The quotation information on page 71, bid item #39 of the bid should request the following information separately: the case price, CRV price, case price with CRV and extension with CRV.

Please discard page 71 of the subject bid and replace with the revised page attached.

3. Question: Do you have any further information for the item listed on pages 63, are you requesting an "unbleached" whole wheat white flour? Do you have a spec sheet?

Answer: The specified description on item #31, page 63 of the bid is: "Flour, fine ground white whole wheat flour". Unbleached or bleached is acceptable. Unfortunately, we do not have a spec sheet to provide at this time.

4. Question: In the bid there are three different references indicating what forms are to be attached for each product quoting. In the mailed bid package "yellow page" When Applicable, provide the following items with your bid: My question is what is "End Product Data Specifications (EPDS)"?

Answer: End Product Data Specifications Sheets are required from Manufacturers that have agreements with the State of California to process USDA Donated Foods into finished products. The "yellow page" that was included in the mailed bid package states, "When Applicable" to provide an EPDS. It does not apply to this bid, FS385-1920/61.

5. Question: Then on Page 32- Copy of the case label? We have to have this even on approved brand names?

Answer: Yes, copies of case labels are required, including for the approved brand names. Failure to do so may result in disqualification of the bid.

6. Question: Page 33 – Choose California Act, is that required if none of the products are produced in California?

Answer: Page 20, paragraph 56. Choose California Produce Act states that ...” all bidders to provide information of where the supplies and produce is grown, manufactured or produced for each item submitted on the bid. The District may deem a bid as “unresponsive” and ineligible for contract award for failure to include this information with their bid.”
