Closed Enrolled Sites

The Long Beach Unified School District is participating in the Summer Food Service Program (SFSP). Lunches will be provided to enrolled children free of charge at following closed enrolled sites. Although enrollment priority is given to the school of resident students, any students may attend any of these sites pending space availability. Enrollment questions should be directed to the Site Director of the Winners Reaching Amazing Potential (WRAP) at each site. Acceptance and participation requirements for the SFSP and all activities are the same for all children regardless of race, color, national origin, sex, age or disability, and there will be no discrimination in the course of the meal service. **Sites are open Monday to Friday but closed on December 26 and 27, 2016, as well as January 2 and 3, 2017.**
