NOTICE INVITING BIDS

NOTICE IS HEREBY GIVEN that the Long Beach Unified District, acting by and through its Governing Board, hereinafter referred to as "District", will receive, prior to 2:00 p.m. PST on 4/4/2017, sealed bids for the award of a Contract for the following: RFB 40-1617 - Surface Seal and Asphalt Repairs at Emerson, Maintenance and Robinson. The bid documents are available at 2201 E. Market Street, Long Beach, CA 90805 and on our District website at http://www.lbschools.net.

All bids shall be made and presented only on the forms provided by the District. Bids shall be received in the Purchasing Department at 2201 E. Market Street, Long Beach, CA and shall be opened and publicly read aloud at the above stated time and place. Any bids received after the time specified above or after any extensions due to material changes shall be returned unopened.

There will be a Pre-Bid Meeting/Job Walk on 3/23/2017. Bidders are to meet at 2201 E. Market St. Long Beach CA 90805 at 9:00 a.m.

Each bidder shall be a licensed contractor pursuant to the California Business and Professions Code, and be licensed to perform the work called for in the Bid Documents. The successful bidder must possess a valid and active Class <u>C-12</u> License at the time of bid and throughout the duration of this Contract.

Each submitted bid must be accompanied by one of the following forms of bidder's security: (1) cash; (2) a cashier's check made payable to the District; (3) a certified check made payable to the District; or (4) a bidder's bond executed by a California admitted surety as defined in Code of Civil Procedure section 995.120, made payable to the District in the form set forth in the Bid Documents. Such bidder's security must be in an amount not less than ten percent (10%) of the maximum amount of bid as a guarantee that the bidder will enter into the proposed Contract, if the same is awarded to such bidder, and will provide the required Performance (if applicable) and Payment Bonds, insurance certificates and any other required documents. In the event of failure to enter into said Contract or provide the necessary documents, said security will be forfeited.

Separate Payment and Performance (if applicable) bonds, each in an amount equal to 100% of the total Contract amount, are required, and shall be provided to the District prior to execution of the Contract and shall be in the form set forth in the Bid Documents. All bonds must be issued by a California admitted surety as defined in California Code of Civil Procedure section 995.120.

The Contractor and all Subcontractors shall comply with the requirements set forth in Division 2, Part 7, Chapter 1 of the Labor Code. The District has obtained from the Director of the Department of Industrial Relations the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work in the locality in which this work is to be performed for each craft, classification or type of worker needed to execute the Contract. These per diem rates, including holiday and overtime work, as well as employer payments for health and welfare, pension, vacation, and similar purposes, are on file at the District, and are also available from the Director of the Department of Industrial Relations. Pursuant to California Labor Code section 1720 et seq., it shall be mandatory upon the Contractor to whom the Contract is awarded, and upon any subcontractor under such Contractor, to pay not less than the said specified rates to all workers employed by them in the execution of the Contract.

SPECIAL PROVISIONS

SURFACE SEAL AND ASPHALT REPAIRS AT

EMERSON, MAINTENANCE AND ROBINSON

PART 1 – SCOPE OF WORK

The scope of work includes all labor, materials, tools, appliances, equipment, and facilities necessary to do all of the work noted in the specifications. All work shall be done to the satisfaction and under the supervision of the Director of Maintenance or his duly authorized representative. The scope of work at Emerson Parkside Academy, Maintenance Branch, and Robinson Academy includes but is not limited to the following:

Asphalt repairs (remove and replace asphalt at multiple locations), water flood testing of existing paved areas, patching asphaltic concrete, sealing cracks, installation of surface seal, striping and/or re-striping all paved areas, including all paved areas, playgrounds and parking lots, and other related work as described in the plans, specifications, and contract documents, by the reference made a part hereof.

PART 2 – STANDARD SPECIFICATIONS

Except as otherwise provided in the Drawings, these Special Provisions and Technical Provisions, the Work embraced herein shall be done in accordance with the appropriate provisions of the Standard Specifications for Public Works Construction, 2009 Edition, which are hereinafter referred to as the Standard Specifications, and all supplements to date. All Work outside the property line shall also be done in accordance with the City of Long Beach Standard Specifications.

PART 3 – DEFINITION

A.	District	The Long Beach Unified School District hereinafter called "District".
B.	Engineer	The District's Director of Maintenance or his authorized Representative.
C.	Director	The District's Director of Maintenance or his authorized Representative.
D.	Work	All related work as outlined in the "scope of work".



PART 4 - CLEAN - UP

The Contractor shall at all times keep the premises and adjoining properties and public areas free from accumulation of work materials or rubbish caused by his operations. At the completion of the Work, he shall remove all his waste materials and rubbish from and about the project site as well as his tools, construction equipment, machinery and surplus materials. Contractor shall not use District trash container for disposal of debris.

PART 5 – SUBMITTALS

The Contractor shall prepare and submit complete material lists indicating manufacturer, together with description literature and any other material requiring review and approval to the Director within ten (10) calendar days of award of contract.

PART 6 – CONSTRUCTION MEETINGS

The Contractor shall attend job-related meetings as requested by the District.

PART 7 – STORM WATER DISCHARGE CONTROL

The Contractor shall be responsible for insuring compliance with all applicable Federal, State and Local regulations and laws relating to the EPA's National Pollutant Discharge Elimination System (NPDES).

The Contractor shall implement and manage all necessary Storm Water Discharge Control requirements to remain in compliance with all regulatory agencies. There shall be no additional cost to the District for this item of Work.

PART 8 – CONSTRUCTION COORDINATION

All Work shall be performed so as not to interfere with the operation of the school. Planned disruptions or noisy, disruptions to operations must be coordinated with the Principal and or school site Administrator and IOR (Inspector-of-Record).

The Contractor and his subcontractors shall schedule and coordinate with all other Contractors on site so as not to disrupt and interfere with each other's activity.

PART 9 – CONSTRUCTION SAFETY AND SCHEDULE

A. During performance of Work of this Contract, Emerson Parkside Academy, Maintenance Branch, and Robinson Academy will remain in session and buildings and premises will be occupied by students and staff during regular school hours.

All work shall be performed on weekends.



B. Emerson Parkside Academy, Maintenance Branch, and Robinson Academy follow a Traditional calendar.

- C. Contractor shall respect days devoted to SAT Testing and Stanford Testing as well as other critical testing of the students by not producing noisy or distracting functions or activities within the classroom or adjacent areas.
- D. Hours of work: Weekend working hours shall not conflict with applicable City Noise Ordinances.
- E. Work will be permitted in other areas when it cannot be done during its designated phase, upon approval of the District. Work shall not block exits, corridors or stairs, shall not create hazardous conditions or excessive noise and shall not adversely affect operation of the school.
- F. Contractor shall be responsible for maintaining site at all times in a condition befitting school operations, which at a minimum is to be clean, safe, secure and



SCOPE OF WORK

PART 1 – ASPHALT REPAIRS

- 1.01 General: Perform all asphalt repairs in accordance with the Drawings and Specifications. All work shall be inspected and approved by District's Representative.
- 1.02 Pavement section for parking lot: Remove and replace asphalt at parking lot where shown in the drawings and as directed by District representative. Saw cut, remove existing pavement and subgrade as required and construct 4" A.C. pavement over 12" of crushed aggregate base (95% minimum compaction) over 12" minimum recompacted subgrade (90% minimum relative compaction) per specifications.
- 1.03 Pavement section for playground: Remove and replace asphalt at playground where shown in the drawings and as directed by District's Representative. Saw cut, remove existing pavement and subgrade as required and construct 3.5" asphalt concrete (A.C.) pavement over 12" minimum recompacted subgrade (90% minimum relative compaction) per specifications.
- 1.04 Use Crushed Aggregate Base as needed in areas requiring fill, in accordance with the Specifications and as directed by District's Representative. Crushed Aggregate Base shall have 95% minimum relative compaction.
- 1.05 Asphalt grinding: Grind existing asphalt where shown in the drawings and as directed by District's Representative. Clean, apply tack coat and over-lay with 1" asphalt concrete or as required per specifications.
- 1.06 Miscellaneous removals: Demolish, excavate, remove and haul away obsolete equipment or fencing footings and wheel stops. Repair asphalt as required and as directed by District's Representative.
- 1.07 Remove existing tree root system at abandoned tree wells, and where required.
- 1.08 Protect existing trees and tree root system.
- 1.09 Adjust existing yard boxes within improvement areas, where shown in the drawings and as directed by District representative. For yard box detail refer to Appendices.
- 1.10 Tree well reconstruction: Remove and replace redwood headers at existing tree wells within improvement areas. Redwood headers shall be continuous 2" x 6". Tree wells shall be 12' x 12' for trees with 12" diameter or greater trunk size, 10' x
