## **COURSE OVERVIEW:**

This course exposes students to classic and contemporary fiction and nonfiction texts, all aligned to the Common Core State Standards for Grade 9. These texts become a launch for writing in three genres: argumentative, expository, and narrative. The course also includes a thorough review of the principles of grammar and punctuation, and strategies of effective writing. Emphasis is placed on preparation for the successful completion of both the SBAC and SAT.

#### **EXPECTED OUTCOMES**

Students are expected to perform at a mastery ("Standard Exceeded") level on a variety of tasks and assessments aligned to the Common Core Standards for English Language Arts / Literacy addressed in English 1-2. Levels of proficiency are defined near the end of this course outline under Performance Criteria.

They seek counselors, mentors, and other experts to assist in the planning and execution of education and career plans.

### 4. Apply technology to enhance productivity.

Career-ready individuals find and maximize the productive value of existing and new technology to accomplish workplace tasks and solve workplace problems. They are flexible and adaptive in acquiring and using new technology. They understand the inherent risks - personal and organizational - of technology applications, and they take actions to prevent or mitigate these risks.

#### 5. Utilize critical thinking to make sense of problems and persevere in solving them.

Career-ready individuals recognize problems in the workplace, understand the nature of the problems, and devise effective plans to solve the problems. They thoughtfully investigate the root cause of a problem prior to introducing solutions. They carefully consider options to solve a problem and, once agreed upon, follow through to ensure the problem is resolved.

### 6. Practice personal health and understand financial literacy.

Career-ready individuals understand the relationship between personal health and workplace performance. They contribute to their personal well-being through a healthy diet, regular exercise, and mental health activities. Career-ready individuals also understand that financial literacy leads to a secure future that enables career success.

## 7. Act as a responsible citizen in the workplace and the community.

Career-ready individuals understand the obligations and responsibilities of being a member of a community and demonstrate this understanding every day through their interactions with others. They are aware of the

impacts of their decisions on others and the environment around them, and they think about the short-term and long-term consequences of their actions. They are reliable and consistent in going beyond minimum expectations and in participating in activities that serve the greater good.

## 8. Model integrity, ethical leadership, and effective management.

Career-ready individuals consistently act in ways that align with personal and community-held ideals and principles. They employ ethical behaviors and actions that positively influence others. They have a clear understanding of integrity and act on this understanding in every decision. They use a variety of means to positively impact the direction and actions of a team organization, and they recognize the short-term and long-term effects that management's actions and attitudes can have on productivity, morale, and organizational culture.

## 9. Work productively in teams while integrating cultural and global competence.

Career-ready individuals contribute positively to every team, as both team leaders and team members. To avoid barriers to productive and positive interaction, they apply an awareness of cultural differences. They interact effectively and sensitively with all members of the team and find ways to increase the engagement and contribution of other members.

## 10. Demonstrate creativity and innovation.

Career-ready individuals recommend ideas that solve problems in new and different ways and contribute to the improvement of the organization. They consider unconventional ideas and suggestions by others as solutions to issues, tasks, or problems. They discern which ideas and suggestions may have the greatest value. They seek new methods, practices, and ideas from a variety of sources and apply those ideas to their own workplace practices.

## 11. Employ valid and reliable research strategies.

Unit 1: American Voices

**Duration:** 30 days

**Description:** The people who call the United States home are diverse in their histories and experiences. Is there such a thing as a "correct" way to be "American"? Students will read and respond in writing to many examples about how the diversity of American voices reflects the diversity of the American people.

## **Required Assignments:**

- Writing Performance Task: Write a Nonfiction Narrative Students will consider how the idea of American identify has changed over time. Then, they will use their own experience, or that of someone they know or have studied, to write a brief narrative that explores the essential question: How does your generation define what it means to be an American today?
- <u>Speaking and Listening Performance Task:</u> *Produce a Podcast* Students will work with a group to develop a podcast that addresses the question: How do the realities of immigrants' experiences reflect or fail to reflect American ideals?
- Analyze Craft and Structure: Purpose and rhetoric, persuasive appeals, internal vs. external conflict, complex characters, informative text features, autobiographical writing, poetic structures

Unit 2: Survival

**Duration:** 30 days

**Description:** The quest for survival is a powerful human instinct. What determines who lives and who dies? In this unit, students will engage in various textual formats to help them to determine what the word survival suggests to them; they will then express their new learning in writing by considering what it takes to survive and who is responsible for covering the costs of survival.

### **Required Assignments:**

- <u>Writing Performance Task:</u> *Write an Argument* Students will take into account the knowledge gained by reading various texts and take and defend a position on the topic of survival: "Should the narrator of 'The Seventh Man' forgive himself for his failure to save K.?"
- Speaking and Listening Performance Task: Present an Argument Students will work with a group
  to develop and refine a multimedia presentation about emergency situations to present to a school or
  civic group.

- Analyze Craft and Structure: Author's choice in order of events, development of ideas, narrative nonfiction, author's perspective, complex characters, author's claims and ideas, development of theme

## Unit 3: The Literature of Civil Rights

**Duration:** 30 days

**Description:** During the Civil Rights movement, writings and speeches inspired sweeping social change. What gave those words the power to change a nation? Students will read many examples about the literature that arose from the civil rights movement, which led to widespread social reforms.

Unit 6: World's End – Optional Unit

**Duration:** 30-45 days

This extension prompt requires thinking beyond the concept of the "end of the world".

These are end-of-learning assessments to demonstrate competency in comprehension, analysis, synthesis, evaluation, etc. These tasks are primarily unassisted student assessments. Some examples include the following:

- Reading & Writing Tasks: Making Meaning, Language Development, and Effective Expression Writing Tasks 25%
  These tasks provide students with opportunities to "attempt" or "discover" multiple strategies in their learning of
  new or reviewed skills. This process allows for multiple submissions to master the learning without penalty. These
  are primarily teacher-guided or collaborative tasks that may include scaffolded supports. Some examples include
  the following:
  - Performance Task: Writing Focus (teacher-guided process essay), including pre-writes, Thinking Maps,
     Flee Maps, drafts, peer feedback, etc.
  - Thinking Maps
  - Unit and section introduction tasks: section overview activities, Launch Text activities

Preparation and participation in effective collaborative conversations. These conversations are built around important content so that students may show competency in contributing appropriately and analyzing and synthesizing a multitude of ideas from a variety of sources. These assessments allow teachers and students to collect the best possible evidence about where students are

These mini-assessments can be oral, multiple-choice, short answer, essay format, or visual. They can be graded or not. Some examples include the following:

- o Brief guizzes and general comprehension checks
- Thinking Maps
- Selection Tests

## Homework (District Recommendation)

10% (at the most)

This independent practice reinforces or extends the instruction or learning done in class. Teachers use the data to determine areas of focus for student intervention (reteach) and/or acceleration (move on). The work should be checked for completion, but not graded for mastery: it is practice in a skill. Homework could be: spelling, reading logs, SSR, vocabulary, grammar practice, rough draft revision, long term project work, journal writing, annotation/note-taking, etc.
